 - iii. CJ moves to approve the minutes from the 2023 TSJCL State Convention & Winter Board Meeting.
 - iv. Julius seconds the motion.
 - v. The motion passes and both minutes are approved.
- c. TXSCL Report, 2022-2023 TXSCL Officers
 - i. The TXSCL will be judging the Meme Wars between Virginia and Florida SCL.
 - ii. Emma Buhrman also attended state and gave away SCL shirts, which will also be available at Nationals, as prizes.
 - iii. She also talks about their Instagram and the Historian's plans to update the website.
- 4. New Business
 - a. President's Remarks, Baala Shakya
 - i. Jacqueline Huang passes the gavel to Baala Shakya. She says, "You've always had the responsibility of holding the Torch, and now you'll hold the gavel."
 - Baala Shakya says how nice it is to be here and to serve as the 2023-2024 TSJCL President. She says hello to the new Board, and goodbye to the old one.
 - b. Convention Report, Jenny Sohn & Noorain Aziz
 - i. The 2023 State Convention report covers the following:
 - 1. There were 1239 TSJCL members, 189 sponsors and chaperones, and over 200 volunteers in attendance.
 - 2. Having a detailed registration packet, concessions run by the host school band, and maintaining large and clear signage proved to be very helpful.
 - 3. Regarding volunteers, posting some at heavy traffic areas and holding a check-in table, as well as recruiting them via Signup Genius made the process much easier.

- 4. For catering, ensuring that there are regular, vegetarian, and gluten-free options, as well as requesting bottled water and donated items for a teacher's lounge is important.
- 5. Allotting three hours for Certamen finals and two hours for the final awards assembly seemed to work well.
- 6. Lastly, the report suggests a sound system for sponsor and chaperone meetings, as well as having student officers suggest songs to the DJ.
- c. Treasurer's Report, Natasha Chamitoff
 - i. Natasha pulls up the Treasurer's Report. She hopes to help the next Treasurer pull in more donations. Fundraiser wristbands will be sold at the next Convention.
 - ii. Natasha thanks those who came to the Treasurer Advisory Committee and made an informal slideshow to discuss the proposals made at the meeting. The deficit of \$14,863.32 is much lower than the predicted \$23,806.20.
 - iii. Natasha goes through all of the suggested proposals that were brought up at the Treasurer Advisory Committee.
 - iv. Mr. Hagen says that Spring Board Meeting is the most expensive because of the incoming and outgoing officers. The Fall Board Meeting this year was expensive because of the Constitutional Revision, an event that occurs once every five years.
 - v. Mr. Ellis says that it may be better to keep it flexible so that either the Winter or Fall Board Meeting can be virtual.
 - vi. Mr. Hagen says that TSJCL never had a major fundraiser. If the fundraising initiatives are successful, the rest of the proposals are moot.

 - i. There were a lot of ribbons left over. There was at least one trophy that has not been claimed and will not be claimed, so it will be the responsibility of the incoming First Vice President to claim them.

- g. Officer GroupMe Creation, State Chairs
 - i. Ms. Read says that TSJCL officer emails are the official form of communication for the TSJCL. The GroupMe is just an aid, and a State Chair will serve as a monitor for the GroupMe.
- h. Announcements, State Chairs

- i. Mr. Lee says that officers represent TSJCL in everything that they do. They need to check emails every 24 hours and ensure that they are good representatives for the TSJCL. He asks that officers check with their sponsors if they have questions.
